Evaluation Extension rules that apply to both types of extensions:

1. Extensions may be taken on a triennial reevaluation provided that the reevaluation is completed on or prior to the three year anniversary date.
2. Maximum of 3 extensions may be taken. If an EOY extension is taken then a maximum of 2 parentally approved extensions may be taken after that.

End of Year Extension

If the LEA begins an evaluation and there are fewer than 60 business days remaining in the LEA's current school year, the LEA may take this type of extension with parent permission. However, the number of days used between the parental signature and June 1 (the SER official beginning date of summer) will be subtracted from the 60 business days, and the timelines will begin again on September 1 (the SER official ending date for summer).

Parentally Approved Extension

Parent may grant approval for an extension of 1-30 days on an evaluation.
