eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- Why are there two links on the LRE page for Permission for Medicaid Billing, nothing is linked to it. Thought this was peculiar. Not sure the purpose it would serve. Student Dropdown: Test Student Profile
 - Ann Broussard - Lafayette - SER Data Coordinator Secretary
 - Issue has been provided to eSER Project Management team
- I am trying to access the actual current and previous IEPs for students and says "No IEP Lists records found" and this student has a current and previous IEPs.
 - Charlotte Fasola - Washington - Educational Diagnostician
 - The student may not have an actual IEP in eSER staging. The data in eSER staging is test, de-identified, and in some cases completely fake data.

eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- "Site Determination" on the last page of the IEP - there's a dropdown box, but only some of the schools in our district are listed. In SER Legacy, this was automatically generated. Will this also be the case in eSER?
 - Hope James - Speech Therapy Supervisor
 - The individual sites for LEAs will be added in the site determination section drop down menu.
 - I have verified with eSER Project Management team the info will be added to the drop down menu.
- Also, the "save" button is in a different location for the Accommodations page. I personally think it should be in the same place for every page. (For the sake of consistency.)

 - The save button on the accommodation page has been added in the current format, so LEAs have the ability to save each section.

eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- Hello, why is there no section to add minutes in the IEP. See the attachment. It has the part where you put in the amount of minutes per day and # of days per week.
- Where is the section to add the services the student will receive and the reg, community, sped minutes and the calculated total minutes. I see it is correct in the ESY section.
- Also there is no less than weekly link for those receiving services 2x a month.

- Another tester opened the eSER. She pulled a student. In the IEP section schools are populating. On my login they are not populating and won't let me add any schools.

eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- As explained before we are having our staff create User IDs for myla.gov in anticipation of eSER going live in July. I gave explicit instructions they were not to use their legacy SER user ID as the myla.gov User ID. Some have done it anyway. Is there anyway the following accounts can be deleted? I will get them to create another account.
 - Ann Broussard - Lafayette - SER Data Coordinator Secretary
 - There is no way to delete MyLa Accounts.
 - If LEAs decide to use the same email address for a second MyLa account, then they will need to do the following:
 1. Update the email address on the invalid account to a new valid email address.
 2. Log into the new email address and verify the email change via the link.
 3. Create a new MyLa account using the original email
 4. Verify the new MyLa account via new link sent to original email
 5. Have the eScholar Staff ID coordinator update their MyLa username

eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- I probably missed this in one of our meetings but I'm assuming we won't have to list services to providers by SSN anymore or is that just not included in the beta testing? If so, there also won't be a need for "person with IEP authority" section under services? I used the "service provider bulk update" function located under "tools" to move students to different teachers and schools in our parish. Will there still be a way to mass load students from one school to another? Also will there still be a way to change students to different sites in our jurisdiction without closing a jurisdiction and opening a new one?

 - The Service Bulk Provider feature will exist in eSER
 - You will still be able to change students site code within the current LEA

eSER Features - Testing Notes and Concerns (as of 5/18/22)

Feature / Concerns

- We have 4 pupil appraisal staff who would test the RDR site in SER. From what I understand this feature is not available at the moment; therefore, these staff members may not be access the eSER site to beta test.
- I have added a file of the screenshot to show what part of SER I am speaking of.

 - **The RDR feature has not been developed as of yet.**
- I know we just started the beta testing; however, there are issues in the selection of our school sites for our students.
- I have attached a file that explains what we have now that does not seem to be available in eSER.

Feature / Concerns

- As with the "Relink from Escholar" ; I am guessing "add student" is not available since we are not working with live data.
- Also, I was curious and jumping around in the program...under Evaluation there is no "+" there. Will this be coming soon - or will the eval data populate some other way in SER?

- I wanted to test to see how to access PII from Escholar to test how it would work. I clicked on Relink from Escholar, copied and pasted the state ID in the pop up box. However, I could not click on the relink to make it complete the process.
- The relink is there but it is not working. I get a red circle with a red slash...does it mean it is not ready?

 - If you are still receiving the red circle when selecting the Relink feature, that just means the feature has not been developed yet.

eSER Features - Testing Notes and Concerns (as of 5/23/22)

Feature / Concerns

- Can't validate, make official, or submit IEP. Can't add service to the Program Services page. I can add a TimeFrame but can't add services (Special Ed, Speech, OT, PT, Counseling, etc).

- If student has a current IEP, the +Add button is not available to add a new IEP. I can edit/view the IEP. I can't find a way to amend the IEP. If there's a button or link somewhere, I can't find it.

eSER Features - Testing Notes and Concerns (as of 5/23/22)

Feature / Concerns

- Tried to search by school code. Results produced showed list of all students, not the school code entered. Tried to search by DOB. Results were blank. Yes, I know I had a dob of an active student enrolled. Searched by local ID worked.

- Tried to do a search by provider (see provider ID search 1, attached). Got error (see provider search 2, attached). Not sure if it's because there are no providers listed in eSER or not.

eSER Features - Testing Notes and Concerns (as of 5/23/22)

Feature / Concerns

- When trying to create step-by-step instructions for our SPED teachers eSER setup, we are unable to see the eSer Application in the drop-down in registration.edlink.la.gov. Do you know when this will be made as an option for selection?"

 - The eSER application has not been put in to production as of yet.

- When typing on the IEP, I have noticed the comment section is not available if NO is selected. Is this just part of the testing program? Will comment boxes all be allowed to be typed in no matter what answer you choose on the IEP for comments if necessary on the live program?

- Can accommodations that are not applicable be grayed out? Example see upload. On LEAP Connect those features are already embedded in testing we usually would not have to check them. LEAP Connect page was added but there is not a SAVE button on that page.

 - Issue has been provided to eSER Project Management team
- How often will passwords need to be reset in eSer? We can not view previous IEP's. Is that feature not yet developed? Evaluation tab - We can not add eval participants. Can we remove the pencil so we can type directly in the boxes?

 - Passwords will not need to be reset in eSER
 - Previous IEPs will take place with the rollover of data
 - No, the pencil will not be removed. This feature is a fundamental structure to the system and allows for improved saving, word count, and printing capabilities

Confidentiality Policy Guidance

Annually, a Local security/confidentiality policy should be drafted to include the minimum requirements:

- **Each LEA** should:
 - have a written security policy that includes IEP security.
 - provide security guidelines and policies in local training annually.
- **Special Education Supervisors** or their designated representatives should:
 - govern user access to eSER to ensure confidentiality is maintained
 - work with the local Security Coordinator in performing an annual or semiannual review of users authorized to access eSER including eSER IEP Forms access
- **Each user** should:
 - be required to sign a confidentiality assurance statement annually
 - ensure they are in compliance with their LEA confidentiality policy .
- **Each Local Security Coordinator** should:
 - work with Special Education Supervisors to review all user requests for eSER access
 - maintain a current list of users authorized to access eSER including eSER IEP Forms
 - have a written procedure in place to remove eSER access as user status changes occur (employment ends, change in duties, etc.).

Security Terminology

Public IP Address

An *IP address* identifies a computer on the internet or local network. The IP Address is used for whitelisting a computer. Each user must identify the public IP Address of the computer they will be using for eSER Beta-testing. This address can be static (1 IP Address) or dynamic (a range of IP Addresses)

Whitelisting

Whitelisting is a cybersecurity strategy under which a user can only take actions on their computer that an IT administrator has explicitly allowed in advance. The IP Address of each Beta-Testers computer must be whitelisted in order to access eSER.

EdLink Security

A one-stop shop for requesting and approving access to LDOE owned data systems (e.g. eSER). Allows users with various roles in the LEA to have access to data they should see and be protected from data they shouldn't see. Includes a comprehensive audit trail of all access granted; access can easily be revoked when staff members change roles or LEAs.

Totally Automated Security (TAS) vs EdLink Security

Gaining SER System Access: For LEADS Portal and SER access, special education staff and users contacted their local LEA Security Coordinator who determined the level of access needed and ensured system access was established using Totally Automated Security (TAS).

Gaining eSER System Access: For eSER Beta-testing, special education staff must request system access by following the EdLink Security guidelines which include the following:

- Identify your Public IP Address(es) for Whitelisting Your Computer (required for Beta-testing only)
- Create an EdLink Username and password at:
 - <https://bat.My.LA.gov> (required for Beta-testing only)
 - <https://My.LA.gov> (credentials must be identical)
- Ensure your StaffID is linked to the Username created in the step above. Each staff person is assigned a StaffID reported in the eScholar StaffID system and in EdLink 360.
- Using the Registration link for eSER Beta Testing <https://stg.registration.edlink.la.gov>, request the *Location, Application, Role* and *Permissions* in EdLink Security.
- Location: District or school location based on user role and permissions

Linking Your StaffID to your Username

Work with your eScholar Data manager to have your StaffID linked to the Username you created at <https://bat.My.LA.gov> and <https://My.LA.gov> (credentials must be identical)

- eScholar StaffID link: <https://louisianastaffid.escholar.com/uid/login.do>
- In eScholar StaffID, search for the person by the first/last name or by StaffID
- Select the appropriate record
- Select the EDIT STAFF button at the bottom right of the page
- The Customer Defined Field will appear (see under the address section)
- Enter the **Username** you created at <https://bat.My.LA.gov> and <https://My.LA.gov>
- Select the UPDATE STAFF RECORD button at the bottom right of the page
